Several years ago, the NFRBMEA Board of Directors asked Dr. Edgar Persons to look into an expanded role for NFRBMEA in pre-service and in-service professional development. Dr. Persons developed an idea that goes well beyond our current emphasis on our annual conference. His idea has become known as the "National Institute".

The "National Institute" is NFRBMEA's vision to become the premiere source for preservice and in-service professional development opportunities in farm and ranch business management education. The National Institute is considered a potentially powerful tool to improve teacher recruitment and retention.

The National Institute involves NFRBMEA working with a major university or universities to offer college credit for educational activities at our annual conferences as well as in other places and other times. Funding would be adequate to allow qualifying teachers to take these courses at minimal cost to themselves. Dr. Richard Joerger, University of Minnesota, has taken an interest in helping the NFRBMEA with the planning phase of a National Institute.

#### National Survey

Dr. Joerger was commissioned to conduct an online survey to determine the pre and inservice professional development needs of our members. 143 instructors and administrators from 15 states responded to the survey. Dr. Joerger presented his preliminary findings to the Board at their Fall 2003 meeting and will present a detailed report at the 2004 Conference. The results of the survey will also be presented at the Change in Rural America Conference in June 2004.

# **NAFBAS** Cooperation

Early in 2003 Past President Jim Kelm was contacted by Bob Rhea Executive Director of NAFBAS (National Association of Farm Business Analysis Specialists) regarding possible cooperation between the two organizations. Bob was invited to visit with the Board at the pre-conference meeting in Minot. At that meeting another meeting between NAFBAS and NFRBMEA was set for Des Moines in September of 2003.

During these meetings and other conversations it became apparent that the two organizations are almost identical in size, mission, budgets, and clientele. During the Des Moines meeting it was determined the two organizations have 400 staff members serving 40,000 farms in 25 states.

The first cooperative effort of the two organizations will be the 2006 Conference. Other long term planning possibilities include:

- Co-participation in USDA grants for delivery of financial management to farmers and ranchers
- Professional development opportunities for members

- Development and delivery of National Pork Board educational projects
- Compilation, study, and publishing of farm analysis data
- Sharing administrative responsibilities
- Enhancement, maintenance, and updating of web pages
- Secure major sponsors for conference and organizational financial and in-kind support
- Enhance the role of the two organizations in the Farm Financial Standards Council

The next joint meeting will be held on September 29<sup>th</sup> in Champaign, IL.
