History of NFRBMEA, Inc.

In 1973, instructors using the farm/ranch analysis developed in Minnesota, were invited to Faribault, Minnesota, for three days to participate in an exchange of ideas and to make improvements to that analysis. The instructors enjoyed and learned from each other's experiences so much it was decided to meet again next year. Instructors wanted to show what was going on in their state, leading to continued yearly conferences in other states conducting adult farm/ranch business management education programs. The association was named and the constitution was ratified at Pierre, South Dakota, in 1985.

We are an association of Farm Business Management (FBM) instructors who work in approximately 20 states and provinces. These instructors each work with 40-50 farm operators on a yearly basis. They both teach and consult with these farmers on business planning & analysis, financing & credit, cash flow budgeting, business accounting, tax planning, financial ratios, and financial benchmarking.

The NFRBMEA meets annually and continues to expand its activities to serve its members. Each conference has workshops, tours and top-notch speakers. Information is designed to be taken home and put to use.

Knowledge disseminated and networking created by our organization has a direct impact on making better farm business managers and strengthens the whole agricultural community.

Our newsletter, the **NUTS & BOLTS Real-Time Update**, is distributed electronically at least three times each year. Each issue is full of useful information chosen from the best current ideas in farm and ranch management education submitted by members and others.

The National Council for Agricultural Education Jay Olson, Council Representative

It is my pleasure to follow Rich Baumann as the adult representative on the National Ag Ed Council. I started my 3 year term in January and will continue through December of 2010.

The Council has had an Adult Level Instructor Representative for many years, and often that has been an NFRBMEA member. However, since 2005, the NFRBMEA officially has been authorized to appoint this representative. This stands as a solid recognition that NFRBMEA is a full fledged member of Team Ag Ed in the U.S.

The National Council for Agricultural Education (The Council) serves as the umbrella organization for the agricultural education community. The Council is made up of representatives of each of it's 10 member organizations as well as representatives of the American Association for Agricultural Education (AAAE), the National Association of Agricultural Educators (NAAE), the National Association of Agricultural Educator (NASAE), the National Association of Supervisors of Agricultural Educator (NASAE), the Ag Ed Division of ACTE, and exofficio members from the U.S. Department of Education, National FFA and others deemed appropriate.

Since it's beginning in 1983, The Council has provided leadership for stakeholders in agricultural education in grades 7 through adult in all 50 states and 3 U.S. territories. It serves as a common meeting ground for entities representing students, teacher, teacher educators, state leaders, alumni, industry, and government. The Council meets during the year on conference calls and twice each year in face to face meetings.

The Council proactively shapes the future of agricultural education. It identifies and provides solutions to relevant issues, coordinates efforts to strengthen Agricultural Education programs and serves as a national advocate for agricultural education.

The Council manages a portfolio of initiatives that will contribute to the long-range strategic goals of Agricultural Education. These goals include overseeing National Program Standards, National Curriculum Standards, advocacy efforts, innovative curriculum models, career clusters, the National Research Agenda, business/education partnerships and pre-service and in-service support for agricultural educators. A primary effort has gone into the 10x15 goal of 10,000 quality Ag Ed programs by 2015.

Recognizing the ongoing shortage of teachers of Agricultural Education, The Council has a number of proposals and programs to attract new teachers and retain and support current teachers of agricultural education.

A PROPOSAL FOR A NATIONAL PROFESSIONAL DEVELOPMENT INSTITUTE FOR MANAGEMENT EDUCATION AND AGRICULTURAL PROFESSIONALS

Background and Need

Over 400 agricultural education professionals from the National Farm and Ranch Business Management Education Association (NFRBMEA) and the National Association of Farm Business Analysis Specialists (NAFBAS) work with over 40,000 farmers and ranchers each year. After educating thousands of students for many years, a large number of the current farm management educators are now nearing retirement age. As a result, a tremendous need exists for initial and continued in-service for educators if the quality of education is to continue. Recruitment and retention of teachers as well as a provision for professional and continuing education needs will ensure a sufficient supply of informed and effective professionals for years to come. In addition to teachers, professional development needs exist for many other entities within the food and fiber industry. More specifically, perennial professional development needs exist for agribusiness professionals including accountants, rural appraisers, agricultural lenders, insurance agents, pest management specialists, etc.

Quality professional development efforts are informed by timely and on-going assessments of the professional development needs of individuals. Evidence of the nature and need for continuing and professional development by farm business and production management educators was verified for the membership of the NFRBMEA through a study recently completed to determine the professional needs of its members. The findings confirmed that different professional development needs do exist for instructors with differing years of experience and from different types of farm business and production management programs.

The 2008-2011 Otto Bremer Foundation Grant Proposal

A three year \$179,800 request was made to the Otto Bremer Foundation to secure funds to establishment a national professional development institute. These funds would be distributed on an annual basis. Lake Region State College in Devils Lake, North Dakota has consented to act as the fiscal agent for this proposal. At the time of this publication, final approval of the grant request had not been completed.

Professional Development Institute highlights as Proposed in the 3 Year Bremer Grant

- \$60,000 to be used for stipends and expense reimbursement to attend an annual conference.
- \$33,300 to be used for honorariums and production costs of electronic media on Instructional techniques, career highlights, and how to teach adults.
- \$2,500 to be used for an historical documentation.
- \$8,000 to be used for a pilot North Dakota teacher mentoring program.
- \$67,000 to be used for consulting fees and travel expenses of the program administrator.
- \$9,000 to be used to reimburse fiscal agent fees.

Minutes of the NFRBMEA 22nd Annual Business Meeting June 12 & 14, 2007 Rochester, Minnesota

The meeting was called to order on June 12, 2007 at 3:50 p.m. by President Jay Olson

The Secretary's report was handed out in the NFRBMEA 2006-2007 Annual Report, pp. 10-11. Motion by John Woodford to approve the secretary's report, seconded by Larry Klingbeil and the motion passed.

The Treasurer's report was presented by Doug Wertish on pages 12-15 within the Annual Report. Motion by AI Graner to approve the Treasurer's report, seconded by Tom and the motion carried.

Vic Richardson reviewed the treasurer's audit report. He found no discrepancies.

President Jay Olson presented First-Timer's Scholarships to Jory Hansen, sponsored by Jay Olson; Rex Quam, sponsored by John Hobert; Mark Wehe, sponsored by Doug Wertish; Todd Stencel, sponsored by Paul Gorman and Zach Rada, sponsored by Tim Holtquist.

The Secretary conducted the Roll Call of States:

- North Dakota: presented by Al Graner, 14 programs, steady, declining ag population.
- Wisconsin: presented by Ed Ruff, Deans want to revitalize our programs.
- South Dakota: presented by Calvin Pietz, two full-time instructors, problem with funding.
- Arizona: presented by Pat Harrington, one full-time program/instructor, larger farms and more large dairy operations.
- Iowa: presented by Harold Swanson, no programs
- Colorado: presented by Jim McCuistion, Maylon Peters has retired, now 10 full time instructors with 522 students.
- Missouri: presented by Norman Rohrbach, 20 programs with 24 part-time and full-time instructors. State has
 frozen funding until recently, now new monies for new programs.
- Ohio: presented by Bruce Stauffer, 22 instructors at about 60% full-time. Funding is tight.
- Oklahoma: presented by Everett Wollenberg. Change of leadership at the state level. 17 instructors and programs.
- Minnesota: presented by Del Lecy, 78 instructors, 3500 students, we are close to seeing a new State Supervisor. The state received an Organic FBM grant, working on new benchmarking with FINBIN. 2300 farms are in our state database. Received help with recruitment.
- There were no reports from Pennsylvania, Utah, Montana and Oregon.

Rich Baumann reported on the National Council (Team AgEd), he has a copy of the "2005-2006 Annual Report on Agricultural Education" for everyone in attendance. He also discussed his participation in the AAAE 2007 Conference in St. Paul this past May.

A Nuts & Bolts/Membership report was presented by Wayne Pike. We may look at more electronic mailing/website work.

Tim Holtquist reported on the National Council for AgEd and other items that were included in the 2006-07 Annual Report.

Officer Nominations for 2007-08: Tim Holtquist reported from the Past President committee the following open offices are Secretary, the nominee is Rick Morgan; President Elect, nominees are Paul Gorman and Harry Gerdes. These nominees will be voted on Thursday when our business meeting reconvenes. The business meeting was recessed at 4:48 pm to be reconvened on Thursday.

The following Standing Committees conducted short meetings: Resource-Deb Pike & Ron VanNurden; Industry Relations-Ron Dvergsten & John Hobert; National Institute-Tim Holtquist & Clark Hanson.

Motion by Jim Kelm, second by Ron Dvergsten to have NAFBAS in charge for 2009, NFRBMEA in charge for 2010; motion passed.

Doug Wertish presented the 2007-2008 Budget and the 2008-2009 revised Extended Budget. Motion by Doug Wertish to approve the budgets, seconded by Ira Beckman, motion passed.

Laurie Morris gave the Historian's report, with an excellent presentation of past meetings and activities.

Jim Kelm and Gary Thome wrapped up the 2007 Conference Evaluation report.

Independent Auditor's Report

NFRBMEA Board

I have audited the balance sheet and Income Statement of the National Farm and Ranch Business Management Education Association, Inc., as of March 31, 2008 and the related statements of revenues, expenditures and other changes and cash flows for the year then ended. It is my responsibility to express an opinion on these financial statements based on my audit.

I conducted the audit in accordance with auditing standards generally accepted in the United States of America, and the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States. These standards require that I plan and perform the audit to obtain a reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates as well as evaluating the overall financial statement presentation. I believe that the audit provides a reasonable basis for my opinion.
