Announcing... the National Farm Business Management Conference Experience Exchange! By Wayne Pike, 2009-10 NFRBMEA President

NFRBMEA and NAFBAS are cooperating on a new National Farm Business Management Conference event that will bring significant achievements of our members to light. We are looking for members to share their experiences in the new National Farm Business Management Conference Experience Exchange. In essence, we are looking for interesting experiences and stories that we would all like to hear from our colleagues.

The Experience Exchange will feature up to two presentations. Each presentation will be about thirty minutes in length. The presentations will take place during the National Conference in Fargo on Tuesday, June 15, 2010. The presentations must be made by the participant and may include speaking, handouts, PowerPoint or other computerized presentations, slide shows or other self-produced multimedia.

A few examples to get you thinking about experiences to share:

- Perhaps you have traveled to a foreign country and have observed or worked in farm management education or farm analysis there.
- Perhaps you have been involved in the development of a new production technology.
- Perhaps you work in a geographic region that has agriculture which does not include corn and soybeans.
- Perhaps you worked with a student/cooperator/colleague and helped them achieve something remarkable or something initially considered unachievable.

The selection for the two presentations will be made by the 2010 conference planners. Criteria for selection are diversity, timeliness, originality and applicability of the topic to our professions.

<u>Deadline for application is May 14, 2010</u>. Notification of acceptance of submission will be on May 24, 2010. A \$200 stipend will be awarded to each presenter at the conclusion of their Experience Exchange.

Please provide the following information for the National Farm Business Management Conference Experience Exchange application:

- 1. Briefly describe the Experience you would like to present. Include when this experience took place if not continuing in the present.
- 2. Briefly explain how you might present your Experience at the conference. For example, PowerPoint presentation, video, slide show, speaking or combination.

National Council for Agriculture Education Adult Position

The adult position on the National Council for Agricultural Education (NCAE) is an appointment by the National Farm and Ranch Business Management Education Association (NFRBMEA) Board of Directors. Jay Olson, FBM Instructor at Lake Region State College in Devils Lake, North Dakota is currently serving this position on the council. Jay's 3-year term will be completed December 31, 2010.

The NCAE is a 19 member board that represents each of the stakeholder Team Ag Ed organizations. This is a continuing opportunity for NFRBMEA and its appointee to have an impact on the future of Agricultural Education in the United States as a member of the NCAE Board of Directors. National Council Adult Position responsibilities: The individual in this position is the spokesperson for adult education in agriculture. The National Council normally meets face-to-face in March in Washington D.C. and in October at a site chosen by the Council President, usually near his or her home office. These meetings typically start on a Thursday and end on Saturday. In addition, conference calls for the National Council are scheduled periodically. Participation in other agricultural educational meetings and conferences may also be requested. The representative to the Council will be appointed to the NFRBMEA Board of Directors and will attend to the responsibilities of that position during their 3-year term. Please contact <u>Jay Olson</u> or any NFRBMEA board member for further information regarding the duties and responsibilities of this position. The new council member's term begins January 1, 2011.

The person selected for the adult position to the National Council will have to be an Active member of NFRBMEA and an ACTE member. Individuals applying should submit the following information in their letter of application:

- Why you are applying for the adult position on the council
- Why you feel that you would be a good selection for the position
- Your major concerns in regard to agricultural education and adult education in particular
- How your philosophy in adult education is reflected in your adult education program
- Do you have support from your administration to serve in this position?

Applicants should submit a resume that includes:

- Information regarding your educational background and educational accomplishments
- Details regarding your involvement in educational organizations and other organizations on the local, regional, state, and national level

All applicants should also provide 3 letters of recommendation. Please submit applications to:

Deadline for application is September 1, 2010. All applications will be reviewed during the NFRBMEA Fall Board Meeting in September. The NFRBMEA Board will contact the selected individual shortly thereafter.

Interest has been expressed in having a Ride & Room Share page added to the 2010 National Farm Management Conference website, and a Yahoogroup has been created to help members make connections for transportation to/from the conference and/or find roommates. It works pretty much the same as it did last year:

- 1. This Yahoogroup is an unlisted group, and therefore only available to members of the Yahoogroup.
- 2. Go to http://tech.groups.yahoo.com/group/2010_Conference_Ride_and_Room_Share/ to join and post your request yourself. It's easy—click on the blue "Join Me" button. Next, create your YahoolD and password. Follow the instructions to select the email address you want to use for communicating, how you want messages delivered (individual emails or all emails once a day "digest" format), etc. Enter the case-sensitive code provided and click "Join". Click the Post link on the left side of the page to submit your request.

Alternatively, you can email me directly at <u>dapike@myclearwave.net</u> to add you to the member list and post your request.

- 3. When you've made arrangements, you can unsubscribe yourself from the group or email me and ask me to remove you.
- 4. The 2010 Conference Ride and Room Share Yahoogroup will be removed at the conclusion of the 2010 conference.

Requests can be posted and read using your email client (Outlook, etc.) but viewing the group via the Yahoogroups website allows you to view all postings that occurred prior to your joining the group.
